


## President's Message

I'm certain you've noticed, SCHRA functions as an outstanding law abiding motorcycle riding, social, and eating club. We have been doing all three with great expertise for more years than most of us would like to admit. However, as a number of new folks have recently joined our ranks, and a degree of confusion and/or complacency has been apparent during our group rides, I feel a quick refresher course on our more important protocols couldn't hurt:

Show up at the assembly location on time or early to schmooze, with a full gas tank and empty bladder. Unless signaled otherwise (PLEASE pass them on), we ride "staggered" as shown in the following diagram. Spacing needs to be consistently maintained so that we are traveling as a 'cohesive unit' for safety sake, and not like a bunch of ragtag bikers that happened to meet by coincidence! These distances are determined by **time** past a roadside object, not in estimated bike lengths or feet. This is especially important on our crowded freeways, reducing the invitation of cars to pass through us.



We normally do not jockey for or change positions in the group while under way, unless the guy in front of you appears unsafe, is leaving too much space or is riding in the wrong track. If he doesn't correct in a minute or two, as he might be asleep, day dreaming, or just obtuse, pass him gently with a smile. He may be pissed or insulted, but inattention has consequences. When we reassemble after a stop, new positions are perfectly OK, except for 'sweeper' and sometimes designated 2nd bike. If the guy in front of you has loud pipes or is blasting stereo music and it's spoiling your ride, let him know you wish to ride in front of him.

It is imperative for the leader to be constantly checking his mirrors to insure his group is intact, and important for everyone to be aware of what is going on both in front and behind them. If someone behind you has pulled over or separated, you need to speed up and let the RoadCpt know. In traffic and even stopped at intersections, it's a real good idea look behind you for a potential situation. At traffic stops, tighten the formation to make it smaller and faster to get through.

Our rides are intended to be pleasurable rides at comfortable cruising speeds for everyone to enjoy. No speeding tickets ever, and not a chase where you're scraping your floorboards on every turn trying to keep visual contact with the leader, and the group is spread out into a 2nd zip code. Realizing we are for the most part, a group of very experienced riders, it is easy for us to let our subconscious do the driving. That could interfere with our eating and socializing—not good!

One more thing. We have saved several trees by only communicating electronically. We are now a savvy, 21st century computer literate group of folks. Email and texting is either a godsend or a curse, your choice, but it's here to stay. Do everyone a big favor that only takes a few seconds: When forwarding a message, click FORWARD, then drag your cursor over all the addresses and text you don't need or want to send which will HIGHLIGHT it, then click DELETE. That's all it takes to send clean messages without exposing dozens of addresses to spam, etc. And use BCC to "blind copy" your recipients without exposing their names and addresses. Your friends will be appreciative and impressed! Lecture over---class dismissed!




Meet Your Member Sumbudy

The hors d'oeuvres and beverages, excellently presented. And the ribs, tri-tip, chicken, and apple pie, were perfectly prepared.



## Product Corner

#### Thermos Vacuum Hydration Bottle

Hydrate! Hydrate! How many times do you hear this mantra? Living in the Southwestern US and especially Southern California as motorcyclists we are frequently exposed to hot and dry air while riding creating a potentially dangerous dehydration situation.

I have noticed many riders carry the small flimsy plastic water bottles; however these can only keep beverages cool for an hour or so. By transferring the contents into one of these Thermos brand, unbreakable stainless steel, double walled vacuum insulated units (say this five times fast) you can extend the cool factor for up to 12 hours. They fit perfectly into the Harley side bottle mounts, and into most automotive cup holders and carrying holders.

But one of the best features is the "pushbutton pop-up lid" for easy access permitting one hand drinking. No more dirt and road grime gathering on the pull-up device common to most plastic water bottles.

There are two models in this review: Both use the push button release cap to access the liquid and an ample opening to easily fill with the odd size ice cubes available at gas stops. Weighing in at only 1.5 oz they are capable of storing 18 oz of either hot or cold liquid. There are differences between the two models:

Model: 2465 "Open circular tube" extension which allows the liquid to flow free when bottle is tipped up. Comfortable rubber grip making it easier to hold the bottle even if wet. The push button lid has a locking ring although it is not required to be engaged to keep the top closed. It prevents accidental triggering of the cap and most probable spillage of the liquid.

Model HS4040TG4: "Straw type" on-demand delivery system which prevents unwanted spillage and delivers precisely the amount of

liquid demanded. The "Straw" device and its holding base are easily removable for cleaning.

My preference is the straw tube mode: There is no need to tip up the bottle to drink due to the "Straw" and the locking ring is not necessary and would just get in the way if engaged during a one hand operation. As for the rubber grip I have wrapped this model with some of the self-fusing Xtreme Tape (see next month's review) around the bottle to create a waterproof grip.

Available: On line at Thermos.com with many different types and colors. Straw Type at \$21 and Tube Type at \$18. Also available at Target Stores.



Ed Note: After discussing the Xtreme tape with Ron this may not be advisable as a gripping substance because the edge 'rolled up'. An alternative might be Tennis grip tape or....?


